

## **Sweepstakes Official Rules**

**Eligibility:** This sweepstakes is open to individuals residing in the continental United States, Alaska, and Hawaii. You must be 18 years of age or older as of the date of entry in order to enter. Offer void where prohibited.

The grand prize winner will be notified by 2/13/2026 via phone. The prize winner will be notified at least once per business day for five (5) days beginning on the day the entry is drawn and will have seven (7) days to respond to the prize notice. If the prize winner does not respond within seven (7) days from the initial notification, then the Campaign for Ending Hunger will randomly draw a new prize winner from the remaining entries and the first prize winner shall be voided.
